

**Rules for Institute Level Admission**

(FY B. Tech., DSY B. Tech., MBA, MCA &amp; M. Tech.)

1. Institute level admission will be carried out for Institute level quota seats and seats remaining vacant after all CAP rounds.
2. Interested and eligible candidates should apply for these seats on or before as per cut off date

Forms received till 5<sup>th</sup> September 25 will be considered for First counseling round at the Institute's admission centre. The schedule of the same will be displayed along with the merit list on institute website and notice board.

3. Candidates will report to the institute as per their merit (as per schedule) along with all necessary documents and applicable Institute fees.

4. The Institute admission committee/team will verify the documents of the candidate and he/she will be allowed to appear for the counseling round, if found eligible as per rules.
5. Admissions will be conducted as per Rule 13 of the information brochure published by Government of Maharashtra, State Common Entrance Test Cell, Mumbai.
6. If a seat is allotted to the candidate in the counseling process, he/she will have to confirm the admission immediately by paying full fees and submitting all original documents to the Institute.

(If a candidate has submitted his/her documents to other institute then in such condition the candidate should provide the admission acknowledgment receipt of



the other Institute to our institute authorities. It will be the sole responsibility of the candidate to submit all these documents within 4 calendar days to the Institute. If a candidate fails to submit all the documents within 4 calendar days then his/her admission will be treated as cancelled automatically and no fees will be refunded in such case.

7. These admissions will be uploaded on the Government of Maharashtra, CET cell admission portal immediately. The aspiring candidates have to co-operate our institute officials for cancelling his/her previous admission (if any) and confirming the admissions on CET Cell portal.
8. All matters related to admission will be handled by the official admission team only.
